Shipping Terms

FOB Sydney, Melbourne or Adelaide.

Orders

Minimum Order: 50 cases

Goods ordered by the customer are supplied subject to availability. Brokenwood will attempt to meet scheduled delivery dates but it is not liable for any loss or damage resulting from a delay in or failure to supply.

Taxes

Goods exported from Australia are GST free if exported within 60 days from the date that Brokenwood supplies an invoice to the customer for those goods. If the goods are not exported within that period, then GST will apply at a rate of 10%

Returns

All goods are supplied on a firm sale basis unless otherwise agreed in writing, and will not be accepted by Brokenwood for return.

Claims

All claims for shortages, damaged or defective goods must be received by Brokenwood within 7 days after delivery and must specify the relevant invoice number and details of the shortage, damage or defect. Brokenwood is not liable for claims received after this time.

Credit Limits

Brokenwood will determine a credit limit for the customer upon completion of the Brokenwood credit application form. Brokenwood may for any reason terminate the customer's credit at any time and will not be liable for any loss or damage suffered by the customer as a result of termination of the customer's credit or a change in the customer's credit limit. Brokenwood is not obliged to fill an order that would result in the customer's credit limit being exceeded.

Payment

The customer must pay Brokenwood in full for goods supplied by Brokenwood on credit with 60 days of the Bill of Lading date, unless otherwise agreed in writing.
